# **Board Comments**

The total portfolio change for the first quarter of 2023 was +8.73%. As the new board, we are happy to have this growth and performance in the portfolio at the start of our board year. Unfortunately, however, we did not outperform the Dutch market which had a benchmark growth of 9.9%. The main reason for this was that the market's performance in January of this year was much higher than that of De Zilveren Rijder. Nonetheless, for February and March, De Zilveren Rijder did perform better. On another note, on May 31st, 2021, DSM (Knonglijke) was delisted and its shares were tendered. At the moment, De Zilveren Rijder is looking at alternative investments to keep our portfolio diversified and to uphold our strong performance.
