PORTFOLIO UPDATE

We are excited to present our recent portfolio changes. ✓

The market is still extremely volatile because of two main reasons: the rising interest rates and expected inflation. Firstly, we saw that, specifically, the Treasury yields have been rising last months which had significant impact on our portfolio. A large part of our portfolio are technology stocks which were impacted the most by the rising interest rates. We see that the portfolio is still recovering from this correction.

We acquired one new stock, Wheaton Precious Metals Corporation. Wheaton Precious Metals Corp is a precious metal streaming company. The organization is engaged in sale of precious metals, including gold, silver and palladium. It has streaming agreements for approximately 19 operating mines and nine development stage projects. The stock was bought on March 12th for the following reasons:

1. The portfolio was vulnerable for the expected increasing inflation rate. So, against gold and silver. The price of the Wheaton stock is extremely correlated with the price of gold because the cashflow of Wheaton is dependent on the gold price. Our aim was to diversify our portfolio. We expect that the price of gold increases this year due to the expected increasing inflation rates,

which could result in a higher share price for Wheaton.

2. The business model enables Wheaton to generate a net profit margin of 47%! Additionally, the revenue increased with 27% last year. Wheaton expects that the revenue keeps increasing in the future while maintaining their current net profit margin.

3. Wheaton Precious Metals is fundamentally a good organization. The long-term debt to equity ratio is around 3.5%. In our opinion, this indicates that the company is healthy which is the reason that we are confident that the expected growth can be realized.

The purchase of Wheaton Precious Metals results in the following Portfolio:

PORTFOLIO UPDATE CONTINUED...

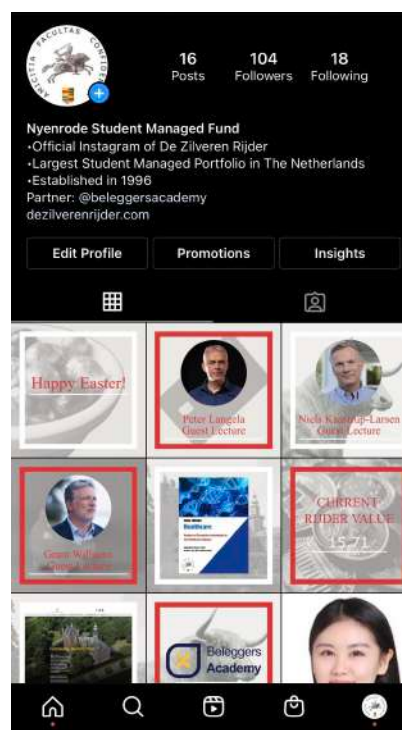
Currently the portfolio has a total value of €152.894 stocks outstanding. Compared to the initial value of 2021, the portfolio increased in value with approximately 6%. Unfortunately, the portfolio isn't outperforming the benchmark of De Zilveren Rijder. The AEX-index increased with approximately 8% during the same period.

However, we are still confident that we will beat the benchmark at the end of the year. Our analysts-teams are currently working on their second analysis, and we believe that they will come up with great investing opportunities.
